PRIVACY POLICY

Interpretation

In this Privacy Policy, when we refer to 'we' 'our' 'us' or the 'Company' we are referring to Isbister Brothers Ltd. When we refer to 'you' or 'your' we are referring to the user of our website and online shop.

Outline of the policy

In this Privacy Policy we will tell you how we collect and use your data when you use our websites and subdomains. We will use it to look after your interests in the best way we can and to ensure the we can properly act on your behalf. We will make sure we collect and store your data securely.

What data do we collect?

We collect name and contact details including your billing and delivery address, telephone numbers and email addresses. We collect identification information from you.

We may collect additional personal data as is necessary to provide our goods and services to you as per your instruction. This can include personal and business financial information, health and medical information, information on your family members and their circumstances.

How do we collect your data?

You directly provide our Company with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- Third Party applications may also collect your information for billing and payment information

Who has access to your data?

Employees of Isbister Brothers Ltd will have access to your data for legitimate processing reasons, such as responding to an enquiry, billing and accounts or delivery information for a purchased product or service.

Unlimited Web Hosting UK Ltd provides hosting services for our websites and may keep any website tracking information as required by law.

Stripe Inc will hold billing information, as well as contact information after purchasing a service online through a Stripe payment portal. More information on their Privacy Policy can be found here: <https://stripe.com/gb/privacy>

Sage Group Plc may have access to billing and accounts data through third party support provided by support technicians.

Our accountant will have access to billing and accounts data for legitimate and legal purposes for the processing of data in preparation for sending to HMRC.

In the event of an unpaid debt we shall share your details with our preferred debt collection agency/solicitor, all based on our legitimate interest, to recover money owed to us.

How will we use your data?

Our Company collects your data so that we can:

- Process your order, manage your account.
- Send relevant information and marketing information with prior arranged consent.

When our Company processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Our Company securely stores your data in compliance with PCI DSS.

Our Company will keep data collected for as long as is required by law, and we will only hold onto data required to fulfil the purposes written in this policy.

Marketing

Our Company would like to send you information about products and services of ours that we think you might like, as well as those of our partner companies.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop our Company from contacting you for marketing purposes or giving your data to other members of the Our Company.

What are your data protection rights?

Our Company would like to make sure you are fully aware of all of your data protection rights.

Every user is entitled to the following:

- The right to access - you have the right to request our Company for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification - you have the right to request that our Company correct any information you believe is inaccurate. You also have the right to request our Company to complete information you believe is incomplete.
- The right to erasure - you have the right to request that our Company erase your personal data, under certain conditions.
- The right to restrict processing - you have the right to request that our Company restrict the processing of your personal data, under certain conditions.
- The right to object to processing - you have the right to object to our Company's processing of your personal data, under certain conditions.
- The right to data portability - you have the right to request that our Company transfer the data that we have collected to another organisation, or directly to you, under certain conditions.

What are cookies?
